UPDATE FROM YOUR LEGAL TEAM

We write to remind you to please review, sign and return the Litigation Funding Agreement below.

The Litigation Funding Agreement is an agreement between you and Litigation Lending Services Limited (LLS) to fund your claim against ISGM.

We confirm that neither the funder, Litigation Lending Services, nor Shine will seek any payment towards any legal costs and disbursements from you, other than from any proceeds recovered from ISGM. If your claim is unsuccessful, you will not have to pay any legal costs to Shine or LLS.

Further, we confirm your participation in the class action will continue to be kept confidential, and will only be disclosed with your prior consent:

- to the Court, if there is a settlement or successful judgment on a confidential basis; and/or
- to ISGM, if required as part of settlement or judgment, to enable verification of your claim and/or payment.

Case Update

Since our last case update to you in March 2020, ISGM filed an appeal against Justice Bromberg's judgment in respect of ISGM's application to 'de-class' this action. The appeal is currently before the Full Court of the Federal Court of Australia and it is anticipated the hearing of the appeal will be in November 2020.

Despite ISGM's appeal, the class action is continuing to progress, and the next case management conference before the Federal Court is scheduled on 11 August 2020. We intend to provide you with a further update after this appearance.

Legal Investigation: Service Stream

Through our correspondence with many of you, we have become aware that a large number of technicians provided services to various telecommunications companies including ISGM and in particular, Service Stream.

It has become apparent that Service Stream employed a very similar work model and practices which short-changed telecommunication technicians out of their statutory employment entitlements, such as minimum wage, annual leave and superannuation.

Shine Lawyers is currently investigating legal action against Service Stream, on similar terms to the [ISGM class action](#).

As part of that investigation, we encourage any technicians who contracted with Service Stream between **2014 to date**, to contact us on a **strictly confidential basis** to assist us in gathering evidence.

Your information will be instrumental in ensuring other telecommunication technicians receive the benefits they are rightfully entitled to, and your support is greatly appreciated.
