On the grounds stated in the accompanying affidavit, the Applicant applies for the following order/s under sections 33K and 33V(1) of the *Federal Court of Australia Act 1976*:

Interlocutory orders sought:

1. Pursuant to s 33K of the *Federal Court of Australia Act 1976* (Cth) (**FCA**) and rr 8.21 and 16.53 of the *Federal Court Rules 2011* (Cth), the Applicant have leave to file and serve a Third Further Amended Statement of Claim in the form annexed to these orders as Annexure A.
2. Pursuant to s 33V(1) of the FCA, the Court approves the discontinuance of the claims of group members who travelled as passengers on the cruises identified in paragraph 1(a) of the Second Further Amended Statement of Claim as the Fourth Cruise and the Fifth Cruise, as effected by the amendments referred to in order 1.
